The YouthCare Pay for Performance (P4P) Program rewards its contracted partners in care for delivering quality preventive healthcare services such as children's and adolescent's immunizations, well-child visits, and weight assessments.

We listened to your opinions and have added an additional, lower target (the 50th percentile) for 2025. Our YouthCare P4P incentives for Primary Care Providers (PCPs) now includes a third target to reward incremental advancement.
